

# **Memorandum of Understanding**

This Memorandum of Understanding (MOU) sets forth the terms and understanding between the **Multiplication Guru** and **the No Name Network** to partner in Church Multiplication.

# **Background**

Bob Carlton, the **Multiplication Guru**, is here to serve **the No Name Network** by helping them multiply their Kingdom Impact. He will leverage his 25 years of church planting experience to help **the No Name Network** make more disciples, develop more leaders, and plant more churches.

#### **Purpose**

Bob Carlton, the **Multiplication Guru**, will help **the No Name Network** build a local/regional/national/global church planting network, build and run a robust church planting operating system, and establish cooperative and collaborative relationships that foster and cultivate a church planting ecosystem.

# Reporting

# **Funding**

Standard <u>VENTI</u> consulting package Services included in VENTI Package:

- Up to 4 days onsite per month (may be divided by  $\frac{1}{2}$  days if necessary)
- Up to 4 virtual meetings per month
- Up to 4 hrs per week offsite R&D
- Unlimited Emails and Texts

In consideration of a one-year retainer, the Multiplication Guru agrees to provide the above services to **the No Name Network** for the base price of **\$8,000.00 per month** plus expenses and/or add ons (see below for pricing specifics). Invoices will be submitted monthly and will include any preapproved addons, and travel expenses.

- Payment is invoiced monthly for convenience
- Prices above are based on a 1 year or longer retainer
- For "add ons" or contracts less than one year, see the "A la carte" rates below
- All travel expenses are based on GSA.GOV rates (by city)

# Duration

Special pricing has been negotiated in consideration of a one-year retainer between **Multiplication Guru** and **the No Name Network**.

This MOU is at-will and may be modified by mutual consent of authorized officials from **Multiplication Guru** and **the No Name Network**.

This MOU shall become effective upon signature by the authorized officials from the **Multiplication Guru** and **the No Name Network** and will remain in effect until modified or terminated by any one of the partners by mutual consent.

In the absence of mutual agreement by the authorized officials from **Multiplication Guru** and **the No Name Network** to end early or extend, this MOU shall begin on **June 01**, **2020** and end on **May 30**, **2022**.
